1. The People's Republic of Bangladesh has received financing from the World Bank toward the cost of the "Bangladesh Regional Waterway Transport Project-1 (BRWTP-1)" and intends to apply part of the proceeds toward payments under the contracts for the Construction of General Cargo Terminal with Allied Infrastructure at Pangaon and Ashuganj.
2. Bangladesh Inland Water Transport Authority (BIWTA) under Ministry of Shipping, Government of the People's Republic of Bangladesh now invites sealed bids from eligible Bidders for the Construction of General Cargo Terminal with Allied Infrastructure at Pangaon and Ashuganj under two Lots of Package No. BRWTP-W2 as mentioned below:

3. The bidding document describes works under above two (2) Lots- each Lot will be treated as separate contract. The Bidders may bid for any number of Lot(s) as further defined in the bidding document. In



- in addition to this bidding package W2 comprising Lot-1 and Lot-2, the Employer is also concurrently carrying out separate procurement processes and inviting bids for the bidding packages W3 and W4.
4. The bidding document specifies the required eligibility and qualification criteria. Any eligible Bidder may participate in bidding process for any or multiple Lots. Bid evaluation of this bidding package W2 and of the separate bidding packages W3 and W4 will be done lot/contract-wise. Contract(s) will be awarded to the Bidder or Bidders offering the lowest evaluated cost to the Employer for combined lots/contracts, subject to the selected Bidder(s) meeting the required qualification criteria for the respective lot/contract and cumulative qualification criteria for the combination of lots/contracts of W2, W3 and W4 as the case may be.
  5. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers, version January 2011/revised July 2014* ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
  6. Interested eligible bidders may obtain further information from Mr. Mahmud Hasan Salim, Project Director, Bangladesh Regional Waterway Transport Project 1 (BRWTP-1), BIWTA and inspect the bidding documents during office hours from 09:00 to 17:00 Hours BST (GMT+6) at the Office of the Project Director at the address given below.
  7. A complete set of the Bidding Documents comprising three (3) volumes in *English* may be purchased by eligible bidders upon the submission of a written application to the address below which may be sent through email from the bidder's official e-mail address to the Employer's email address specified below along with a copy of documentary evidence confirming electronic wire transfer or cash deposit payment of a nonrefundable fee of BDT 25,000.00 (Bangladesh Taka Twenty Five Thousand) or USD 300 (United States Dollars Three Hundred) (**the Bank Transaction Reference Number should be explicitly mentioned**). The method of payment will be electronic wire transfer or cash deposit to the Employer's bank account specified below. **Please clearly mention "Regarding purchase of Bidding Documents for Construction of General Cargo Terminal with Allied Infrastructure at Pangaon and Ashuganj (Package Number: BRWTP-W2)" in the email's subject line.** Within 3 (three) working days of receipt of the payment in the Employer's bank account, the Employer shall send through reply email to the Proposers an electronic copy of the Bidding Documents in PDF format.
  8. Bids must be delivered to the address below on or before **14:00 Hours BST (GMT+6), March 30, 2022**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **March 30, 2022 at 14:30 Hours BST (GMT+6)**. No bidding document will be issued from the Office of the Project Director on the date of submission. The bid opening meeting will also be connected virtually through live video conference, for which the electronic connection details will be sent by the Employer at least Five (5) business days before the bid opening meeting through email to all the bidders who purchased the Bidding Document and who may choose to attend through video conference.
  9. All bids must be accompanied by a Bid-Securing declaration in the prescribed form.
  10. All Bids must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration.
  11. A Pre-bid meeting shall be held at the BSC Tower (Level 19), 2-3 Rajuk Avenue, Motijheel C/A, Dhaka-1000, Bangladesh on **March 02, 2022 at 11.00 Hours, BST (GMT+6 hours)**. The pre-bid meeting will also be connected through video conference, for which the connection details will be sent through email at least five (5) business days before the pre-bid meeting date to the bidders who submitted the written application and purchased the bidding documents.
