Addendum to the Protocol on Inland Water Transit and Trade

Signed on 24.3.2009 between the Government of the People's Republic of Bangladesh and the Government of the Republic of India

In pursuance of the Article 27 of the Protocol on Inland Water Transit and Trade (hereinafter referred to as "Protocol") between the Government of the People's Republic of Bangladesh and the Government of the Republic of India (hereinafter referred to as "Parties"), the parties have agreed to make an addendum to add new routes in the said Protocol.

NOW, THEREFORE, IT IS HEREBY MUTUALLY AGREED as follows:

- 1. For the purpose of mutual benefits of the Parties, an additional route "Ashuganj" in the Bangladesh Part and "Silghat" in Indian Part shall be added in the term "route" mentioned in Article 1.2 of Article 1 of the Protocol and the additional routes including the existing routes shall be as follows:
- Kolkata Haldia Raimongal Chalna Khulna Mongla Kaukhali Barisal
 Hizla Chandpur Narayangonj Aricha Sirajganj Bahadurabad Chilmari Dhubri Pandu Silghat.
- (2) Silghat Pandu Dhubri Chilmari Bahadurabad Sirajganj Aricha -Narayangonj - Chandpur - Hizla - Barisal - Kaukhali - Mongla - Khurna -Chalna - Raimongal - Haldia - Kolkata.
- (3) Kolkata Haldia Rairnongal Mongla Kaukhali Barisal-Hizla Chandpur Narayangonj Bhairab Bazar Ashuganj Ajmiriganj Markuli Sherpur Fenchuganj Zakiganj Karirnganj.
- (4) Karimganj Zakiganj Fenchuganj Sherpur Markuli Ajmiriganj Ashuganj - Bhairab Bazar - Narayangonj - Chandpur - Hizla Barisal Kaukhali - Mongla - Raimongal - Haldia - Kolkata.
- (5) Rajshahi Godagari Dhulian.
